Create the profit and loss statement using the following schema:

Revenue
- Cost of Goods Sold
= Gross Profit
- General and Administrative Expenses
- Depreciation
= Earnings Before Interest and Tax (EBIT)
- Interest
= Earnings Before Tax (EBT)
- Income Tax (1/3)
= Net Profit
